President's Report

It has been an interesting year. I have been involved with the City of Vancouver's Planning Department (as I have for the past 8 years) in developing a home for paddling and rowing down by Science World with the Dragon Boaters, neighbours and developers.

A few months ago I was informed that the City of Vancouver is not interested in pursuing a facility to support rowing down at the east end of False Creek at this time. The Parks Board has been supportive though in making the dream come alive.

Regatta

The regatta continues to grow. We had additional rowers this year: Simon Fraser University entered for the first time and Vancouver College returned after a one year absence. Without the efforts of many of our volunteers we would have been really stuck. Vancouver College, the Kitsilano Yacht Club and the Jericho Sailing Centre's people and safety boats help keep the regatta afloat.

The food remained good from our lone vendor Yolks Mobile Breakfasts, although there were lengthy service delays particularly for the umpires who had to get back on the water. We may need to investigate alternate arrangements to better meet the needs of the people at the regatta and the club.

The Vancouver Rowing Club remained our biggest contingent and supplied many of the volunteers for the event. Their participation continues to mean that the event remains sustainable. Feedback remains positive about hosting the event on the same weekend as Head Of The Fort, particularly for the Victoria City Rowing Club crews who have large overhead for the event due to ferry costs. Attempts to create a co-branded event with Fort Langley remain thin as their priority is in creating an event suitable for their own market.

There were no US crews again. Distributing information at the previous Head Of The Lake in Seattle in early November did not generate any entries. As it is early in the rowing season, there is a high chance that it will remain a local community regatta rather than a major event in the foreseeable future. As we begin to enter crews under our own banner, the volume of competitors may change and it may help create a regatta useful to clubs to create crews for other events such as Windermere Cup in Seattle in early May.

The timing of the event: just before the renewal date for many clubs is also an incentive to retain members by giving them an opportunity to compete ahead of the Junior Regatta in an event that is arguably the end of the head race season.

Boathouse

We have entered into a lease/rental of space at the Burrard Civic Marina under the Burrard Street Bridge, close to the Vancouver College rowing program compound. It is a 20' x 60' space costing about \$3,500 a year.

At present, there is an 8+ in the space, purchased from the University of British Columbia and soon to be a donation to the False Creek Rowing Club through a project we have set up with the National Sport Trust Fund.

Another boat is owned by a member who would like to offer it to the club for use by that member and others in the club.

As a result, there has been more physical evidence of change in the past 3 months than there has been since this project began.

Programming

To make a rowing program sustainable we are in an awkward spot: we need revenue from memberships, but we don't want to offer active memberships without having anything to offer in return. The Rowing Canada Aviron membership page offers "social" memberships in the FCRC for \$50 plus the cost of membership in RCA and Rowing BC (with a choice of sport or competitive membership in those organizations).

Moving forward, we have been examining other rowing clubs and determining their spends on programming and equipment. Equipment costs per member are approximately \$400 per person, and coaching, program and fixed costs approximately \$300 per person.

Other clubs have differing revenue sources for their programs: costs for members are generally offset by lessons, grants and sponsorship, donations, regattas, and product sales. We have been building equipment required to be able to run the regatta at a surplus in the future and have started to sell branded merchandise. Additionally, we have submitted for grants with ViaSport (for oars for our one boat), and for a safety boat for the regatta through the provincial Direct Access Gaming Grants. We have not heard from them at this point.

The City of Vancouver has chosen not to pursue a boathouse at the Science World end of False Creek. They are funding a paddling centre with approximately \$4.2 million worth of funding from a property developer (Concord Pacific) received as a community amenity contribution as they embark on new construction near the north end of the Cambie Street Bridge. Since the Thunderbird Rowing Program stopped providing opportunities to row for the 1,000 people that it once supported in False Creek, there is not enough of a presence to convince senior City staff that this is a wise use of funds.

Therefore, growing organically at the Vanier Park location is the obvious choice. That will require racks, rack rental, a secure storage shack and other governance pieces such as safety plans and procedures, ensuring out waivers are in order and trying to make sense of it all.

Secretary's Report

Her experience in branding and marketing has helped make a difference in terms of the rehabilitation of our web site. Recognizing the ramifications of our web site host provider having security issues resulting in our web site generating pages for visitors that would be deemed inappropriate for any audience, she has helped migrate our web site and email systems with the assistance of Eric Hudson, our service provider and member of the FCRC.

Additionally, the Secretary has been trying to meet with individuals from the Park Board with respect to creating a "cage concept" at Vanier Park prior to our leasing a spot there. Subsequent to our undertaking a rental agreement with the Burrard Civic Marina for our space, she has also endeavoured to have the President not get overexciting and act individually in terms of acquiring equipment. This has been most appreciated by the President, and likely anyone who has tried to get in touch with him.

Regulatory Filings

We have spent the year working with the association's legal counsel ensuring our good standing with the registrar of companies. We are up to date in terms of our obligatory filing with that body and have established routines to comply with this requirement in the future.

Treasurer's Report

She has identified that with the growth of assets comes the dual liability of accounting for them: providing insurance policies to protect against loss of use and depreciating them correctly against their fair market value.

Barbara has presided as our financial advisor for many years. She has ensured that we are properly recording our financial dealings and also ensured that we are registering our membership correctly with Rowing Canada Aviron and Rowing BC. Additionally, she has required us to think carefully about what steps that we wish to take to the road to success. Maintaining our course and developing a plan that we actually follow has been something that Barbara has done for many years for not just this organization, but many others.

She is not standing for re-election this year marking the first time since I have known her that she hasn't had her fingers in one society or another. We thank you Barbara for your good work and the offer to continue to assist us in our bookkeeping functions.

Registration of members with Rowing Canada Aviron and Rowing BC.

We are in complete compliance with RCA's requirement to register all members and volunteers using their web registration system. As a result, we are also fully registered with Rowing BC.

Members with an annual renewal will be issued a membership number from RCA. Where False Creek requires a membership number, we will use the RCA registration number. Life members may use their FCRC issued number which are sequentially distributed based on application order.

NOTES TO FINANCIAL STATEMENTS

March 31st, 2014

(Unaudited)

1. SIGNIFICANT ACCOUNTING POLICIES

Accrual Basis

The club records its revenues and expenditures on an accrual basis.

2. NATIONAL SPORT TRUST FUND

This consists of monies donated to the FCRC "Capital Project". These funds are to be used for the purpose of purchasing depreciable assets and may not be used for operating expenses.

3. LONG-TERM DEBT

This represents a non interest bearing loan from a member. There are not stated terms of repayment.

Strategic Planning

We have immediate needs for discussion:

- Fill the compound with boats renting rack space to cover the cost of the rental.
- Spend about \$2500 on constructing racks to hold rental and club boats.
- Develop a practical operating plan that addresses safety and potentially coaching.
- Develop a fundraising process to afford to buy approximately \$150,000 worth of boat that would fill the space full.
- Create a better succession plan by broadening the number of people involved so that no single individual is responsible for the success or failure of the club.
- Develop a recognition process.

The following items are copied from the Policy Through To Procedures Document and the Board Policy To Procedures Document available on our web site. They may be relevant to the strategic planning discussion that will be help subsequent to the Annual General Meeting.

Strategic Drivers:

- 2. Providing opportunities for youth, disadvantaged participants and adults in the community of rowing through participation as an athlete, coach, official or volunteer.
- 3. Creation of a healthy, well governed community based on the principles of: financial, organizational and environmental sustainability.
- 4. Participation in the rowing community at a municipal, provincial, national and international level.

Goals

We will achieve the following in the pursuit of our mission:

- 4. We participate in the rowing community at a municipal, provincial, national and international level.
 - a. Hosting events in False Creek for the benefit of our members and participants and the broader community.
 - b. Participation in committees, taskforces, boards to promote rowing at a club, municipal, provincial, national and international level.

Section 2: Board Policies

Rowing Operations

- Boat Storage
 - a. Limited storage, if any, will be available for the storage of privately owned rowing shells. To prevent the storage area from being solely the reserve of privately owned boats inaccessible to the general membership, only Founding, Life and Honourary Life Members may store their boats in club owned, leased or operated boathouses.
 - i. Only privately owned singles may be stored in the club's boathouse.
 - ii. The Board will determine a suitable obligations and fees for the annual storage costs of private boats.
 - iii. The Board may terminate the storage agreement of any privately owned boat with 4 months notice without reason.

iv. Obtaining appropriate insurance for privately owned boats is the responsibility of the owner, and copies of the insurance policy must be provided to the club annually and determined to be acceptable to the Board.

Member Services

1. Membership Fees will be approved by the Board and maintained in Appendix 7.

People Management

- 1. We have policies related to Complaint Reporting, Harrassment and Child Abuse and these policies are outlined in Appendix 1.
- 2. Policies related to Human Resources are outlined in Appendix 2.
 - a. Orientation Process is outlines in Appendix 4.
 - b. Performance Evaluation of staff is outlined in Appendix 5.
- 3. Travel policy
 - a. A corporate travel policy has been developed to balance the club's need for cost effectiveness and the employee's need for quality services as outlines in Appendix 3.

Safety & Risk Management

- Water Safety
 - a. All participants, members and coaches involved in water based activities must be competent swimmers.
 - b. All members, staff and participants must make themselves aware of the safety requirements and hazards of the water upon which they row.
- 2. All those involved with the False Creek Rowing Club as participants, members, volunteers or staff will be registered members of Rowing Canada Aviron and Rowing BC.

Organizational Responsibility

- 1. Events hosted False Creek comply with regulatory requirements.
- 2. Board Member's Code of Conduct
 - a. Board members are bound by the Code of Conduct as outlined in Appendix 6.

Appendix 6: Board Member's Code of Conduct

Board members have a responsibility to each other, the membership, and to the employees of the Association. Accordingly,

- 1. They shall attend and participate at Board meetings.
- 2. They shall be prepared for the Board meetings.
- 3. They shall become familiar with this policy manual and the Association's Bylaws.

- 4. They shall make informed decisions by insisting on complete and accurate information and then support all decisions once they have been fully discussed and resolved by the Board.
- 5. They shall show respect for others and their opinions and respect the right of others to disagree.
- 6. They shall actively discipline themselves and other members of the Board of Directors by identifying Board actions and conditions that run counter to these policies.
- 7. They shall bring to the Chair's immediate attention any condition or action that they believe exceeds an Executive Limitation Policy or is in non-compliance with Bylaws.
- 8. The Board commits itself and its members to ethical, businesslike, and lawful conduct, including proper use of authority and appropriate decorum when acting as Board members.
- 9. Members must have loyalty to the ownership.
- In order to develop an unbiased view and reach objective decisions, Board members have an obligation to identify all conflicts of interest and have the Board resolve unacceptable conflicts of interests. Therefore,
 - a. Board members shall disclose to the Chair any potential conflict of interest.
 - b. Unsettled matters shall be reported to the Board for appropriate action.
 - c. Board members shall not accept any gifts or favours of a substantial nature from any organization doing or seeking business with the False Creek Rowing Club (FCRC).
 - d. Board members shall not enter into activities or share information acquired in the course of FCRC service which may adversely affect the Association or public image to FCRC.
- 11. Members must avoid conflict of interest with respect to their fiduciary responsibility.
 - a. When the Board is to decide upon a financial or legal issue, about which a member has an unavoidable conflict of interest, that member shall absent herself or himself without comment from not only the vote, but also from deliberations.
 - b. Board members will not use their Board position to obtain employment in the Association for themselves, family members, or close associates. Should a Board member apply for employment, he or she must first resign from the Board and discontinue future involvement with the Board until such time as the employment with the Association has completed.
- 12. Reimbursement of directors' expenses will be consistent with management operating polices.
- 13. Board members may not attempt to exercise individual authority over the Association, the Chief Executive Officer (CEO) should one exist, or as spokesperson for the Association, unless explicitly authorized by the Board to do so in writing.
- 14. An individual director shall maintain confidentiality as needed to protect the association's interests and financial viability, and personal privacy.
 - Directors shall not discuss confidential association actions, policies, or issues with members, employees, or the general public unless the board has decided that such information is no longer confidential.
 - All issues related to personnel, real estate transactions, pending litigation, and details of association's financial status will be considered sensitive issues subject to confidentiality unless:
 - a. The information in question has already been released without conditions by the CEO or Board,
 - b. The Director is authorized to release the information, or
 - c. Full general disclosure of the information is approved by the Board.
 - c. The expiration of term of office, by termination or otherwise, does not terminate this obligation.

- d. Board Directors will maintain and dispose of confidential materials in an appropriate manner. Confidential materials may be turned over to the CEO for proper disposal.
- e. This policy does not preclude an individual Director from showing the information to personal legal counsel related to concerns of personal liability or wrongdoing. However, a Board decision to seek legal or other counsel is preferred to individual action.
- f. When considering the release of personal information, or other information that may create personal or Board liability, legal advice should be considered.
- 15. The Board members shall follow the chain of command in committee and Board structures which shall be specified as committee chair first, committee second, Board chair third and Board fourth.
- 16. The Board members shall be open to discuss all board issues at the Board table including, but not limited to issues of personal conduct and transgressions of acceptable Board behaviour.

Appendix 7: Membership Fees

Membership Types – Calculated as Indicated

- 1. Rowing Members \$100 per month
 - a. Adult Members (aged 19 or over)
 - b. Youth Members (aged 18 or less)
 - Dues are payable semiannually, in advance.
 - An equipment use fee equal to 6 months dues is payable upon joining, or rejoining the False Creek Rowing Club, in advance.
 - No refunds will be given for prepaid dues or equipment use fees except as legally required, or as directed by the Board Secretary.
 - Fees paid by an individual for rowing lessons or programs provided by the False Creek Rowing Club may be used to offset an equivalent amount of the equipment purchase fee in that calendar year.
 - Non-Resident or Social Membership fees paid in the previous 3 years may be used to offset an equivalent amount of the equipment purchase fee.
 - Individuals who have been classified as Rowing Members of the False Creek Rowing Club for 35 years are exempted from paying further club membership dues.

Membership Types – Calculated Annually

- 2. Social Members \$50 per year
- 3. Non-Resident Members \$50 per year

Membership Types – Non-Recurring

- 4. Founding Members this category of membership is no longer offered.
- 5. Life Members 25 times the annualized rowing member rate.
- 6. Honourary Life Members no membership fee payable7. Honourary Members no membership fee payable

Notes:

- 1. The membership year starts April 1 annually. [amended 2011-05-12]
- 2. No proration of fees or dues is made.
- 3. Rowing BC and Rowing Canada Aviron membership fees are exclusive of False Creek Rowing Club membership fees.
- 4. One of the goals of the sale of Life Memberships in the organization is to create an ongoing fund to purchase capital equipment for the Club, or provide alternative revenue sources in the future, with the intent of allowing for discounted programming.
